General Duties	<ul style="list-style-type: none"> • Support the Catholic Identity of the College. • Understand the relevant compliance imperative. • Contribute to a healthy and safe work environment for yourself and others and comply with all safe work policies and procedures. • Assist with disaster response tests such as evacuations and lockdowns. • Act as a Warden in the event of an emergency response or drills. • Attend staff meetings and after school services/assemblies, sporting events, Mass, community and faith days as required by the Principal. • Demonstrate professional and collegiate relationships with colleagues. • Other duties as directed.
