



## **2026 EDUCATION AND SUPPLEMENTARY FEES**

The 2026 fee schedule has been approved by the Diocese of Sale Catholic Education Limited (DOSCEL). These fees contribute to the delivery of quality education, College facilities, and student services.

### **2026 EDUCATION FEES (PER FAMILY)**

### **2026 SUPPLEMENTARY FEES (PER STUDENT)**

#### **Laptop Program - \$300**

From 2026, all students will continue in the College Laptop Program. Due to increased quality and costs of laptops, software, and IT support, a new annual fee of \$300 will be introduced. The College will subsidise the remaining costs, ensuring students receive a new laptop every three years.

#### **College Private Bus - \$1,500**

Students requiring a seat on the College private bus network will incur an annual fee of \$1,500. This fee is kept low by significant subsidies from the College. Further information about transport options can be found on the College website.

#### **VET (Vocational Education and Training) - \$800**

A VET fee will apply to all students enrolled in a 2026 VET program. This fee contributes toward the cost of external providers, materials, and practical activities. Once a student is enrolled, VET fees are non-refundable.

#### **Additional Charges**

- Extra-Curricular Camps, excursions, immersions, and other activities
- Laptop or property damage
- Private music lessons and instrument hire

These will be invoiced separately during 2026.

## **PAYMENT TERMS**

### **Fee Payment Terms**

All 2026 Education and Supplementary Fees are payable in full by **28 February 2026**, unless an approved payment plan in place.

### **Payment Plans**

Payment Plans will be available through our **new CDFPay App** which will be available in 2026. More information will be provided to families prior to the commencement of Term 1 2026.

## **CONCESSIONS AND HARDSHIP SUPPORT**

### **Camps, Sports and Excursion Fund (CSEF).**

Families in receipt of a valid concession card as per Services Australia (e.g. Health Care Card, Pensioner Card, Veterans card) may be eligible to receive **\$400 per student**. The CSEF application period is from **Tuesday 27 January 2026 to Friday 26 June 2026**.
